Requirements

Credit Achievement

The project must comply with **one** of the following criteria:

- Reconciliation Action Plan
- Inclusion of Indigenous Design

Reconciliation Action Plan

To meet this *Credit Achievement*, the project team must demonstrate that:

- A key member of the Project Team is part of the organisational RAP Working Group
- At least 90% of the RAP targets have been met on the project
- All implemented actions related to the RAP are publicly reported on the project's website

Any design element must be informed by consultation undertaken with the local Aboriginal and Torres Strait Islander community or through nominated representatives.

Where an organisational RAP has already been developed and endorsed, the project is required to adapt this to the project under certification. The project must provide an outcomes document detailing specific engagement, implementation and actions that have positively influenced the outcomes of the project.

Inclusion of Indigenous Design

The project team must demonstrate that the Australian Indigenous Design Charter guiding principles are incorporated in the design of the building including:

- How local Aboriginal and Torres Strait Islander communities have been engaged throughout the design development
- How the project has been designed to acknowledge and recognise the Indigenous culture of the site
- How information on the reconciliation and cultural values of the project will be made available to the public, visitors, and building tenants in the operational phase of the project's life

At a minimum, the following four principles from the [Australian Indigenous Design Charter](#) are to be addressed:

- **Indigenous Led:** Ensure Aboriginal and Torres Strait Islander representation in the creation of the design
- **Community Specific:** Ensure respect for the diversity of Aboriginal and Torres Strait Islander culture by following community specific cultural protocols
- **Impact of Design:** Always consider the reception and implications of all designs so that they are respectful to Indigenous culture
- **Shared Knowledge (collaboration, co-creation, procurement):** Develop and implement respectful methods for all levels of engagement and sharing of Indigenous knowledge (collaboration, co-creation, procurement)

The project team must demonstrate engagement has happened from concept design and continues through to operational handover.

Submission content

Submissions for this credit must contain:

- **Submission form**
- **Evidence** to support claims made in the submission

Recommended evidence:

Reconciliation Action Plan (RAP)

- Extract from the Reconciliation Australia website demonstrating that the project's RAP is endorsed by Reconciliation Australia
- Extracts from the organisation's Annual Report or website (or similar) demonstrating that the RAP is publicly reported upon
- Reconciliation Action Plan Report (or similar) on the outcomes from the project's RAP demonstrating that at least 90% of the RAP targets have been met in the first reporting cycle
- Evidence that a key member of the project team is also on the RAP working group
- Outcomes document linking the project to an organisational RAP

Inclusion of Indigenous Design

- Extract from indigenous engagement strategy
- Evidence of Aboriginal and Torres Strait Islander engagement from concept design throughout the project's life cycle
- As built drawings or photographic evidence of incorporated designs
- Evidence of information being made available to public (e.g., website)
- Comparison against the four principles from the [Australian Indigenous Design Charter](#)

Alternate documentation can also be used by project teams to demonstrate compliance.

The key requirement is that evidence is provided to support each claim made within the Submission form.

Guidance

Engagement

For meaningful engagement to be undertaken, the nominated representatives should be identified and contacted as early in the design process as possible. Best practice guides do exist. Some examples include:

Australian Indigenous Design Charter (AIDC)

The Australian Indigenous Design Charter is a recognised body of researchers from Indigenous Architect and Design Victoria, Design Institute of Australia and Deakin University which have developed a formal protocol on sharing Indigenous knowledge in communication design practice. There are 10 principles developed to ensure the representation of Aboriginal and Torres Strait Islander culture is developed in a respectful manner. These can be incorporated in any form of design ranging from graphics and art to buildings and infrastructure design.

Definitions

Reconciliation Action Plan

“A RAP is a strategic document that supports an organisation’s business plan. It includes practical actions that will drive an organisation’s contribution to reconciliation both internally and in the communities in which it operates.” - Reconciliation Australia

RAPs must be ratified and publicly noted on the Reconciliation Australia website to be viable for use. RAPs cannot be written by project teams without engagement from Reconciliation Australia.
