


#### Removing Barriers & Strengthening Competition Complementary solutions for building products

### Timeline and opportunities for consultation



#### Streamlined consenting system

- Options to make consenting more consistent, simpler and faster:
  - Video and photo evidence
  - More standardised approach to deliver a seamless experience across councils
  - explore self-certification for some groups
  - streamlining Code Compliance Certificates by requiring them to be issued within five working days
- Increasing transparency of information to
  - Quarterly reporting by BCAs on consenting times
  - Identify good practice and areas to improve
- Occupational regulation and consumer protection sit alongside changes

#### Making it easier to build – smaller structures under 60 sqm

- Amend the Building Act and resource consent system to make it easier to build 'granny flats' and other small structures up to 60sqm
  - Make it easier to build small, self-contained homes without building consent
  - Criteria to ensure building safety and support system
- MBIE and MfE developing policy proposals to be consulted upon later this year for RMA and Building Act amendments
- Legislation to be introduced before the end of 2024



#### Immediate changes to improve the system

The Government has also announced several changes to the building consent system, including:

- Defining 'minor variation' and 'minor customisation' to make changes to building consent and Multiproof easier
- Changes to the Building (Accreditation of Building Consent Authorities) Regulations 2006
- Adjustment to the building levy threshold to \$65,000, no change to levy rate



### Seismic work programme

- Goals is effective stewardship of the system to manage seismic risk to buildings.
- Review of Earthquake Prone Building System
  - Ensure settings are workable, effective, proportionate
  - Extend remediation deadlines while Review underway
- National Seismic Hazard Model (NSHM)
  - Review released by GNS Science in October 2022. T
  - Helped to inform a Standards New Zealand draft
    Technical Specification for Structural Design document
    for voluntary use by engineers and designers.
- MBIE recently published the Seismic Risk Resource for Commercial Building Tenants





### Fire safety

- The Government has agreed to a review of the Building Code fire safety provisions.
- In 2024, officials are collecting feedback and consulting on issues in the Fire Safety provisions.
- Once consultation is complete, changes will be made to the Building Code to reflect an updated definition and understanding of fire safety regulation in NZ buildings. Solutions and policy options will be proposed in 2025 or later.
- A timeline for the review is set out below. These timeframes are subject to review.



  - Benefits of modelling












### **Climate Change - Adaptation**

  - Built Environment "Risk to building due to extreme weather events, drought, increased fire, weather & ongoing sea-level rise"
- National Adaptation Plan (2022)
  - Actions for Built Environment
- National Adaptation Framework (2024)
  - Approach to sharing costs & investment
  - Select Committee inquiry
